## COURSE DETAILS

What?	Religious Education in Catholic Schools, Part 1 and 2 are intended to enhance teachers' professional practice through critical reflection and inquiry. In both courses, participants will explore such topics as the mission of Catholic schools; sacred scriptures; spiritual, sacramental, and liturgical life; the Church and a post-modern world; faith in action; ethics and morality; pedagogical practices for religious education; school ministry; and the faith journey related to teaching and learning across the divisions.
Who?	<ul style="list-style-type: none"> <li>Religious Education in Catholic Schools, Part 1 is open to any OCT member with a Certificate of Qualification and Registration who holds qualifications in the Primary or Junior division, or a qualification in the Intermediate or Senior division in a general education subject from the OCT's Schedule A.</li> <li>Religious Education in Catholic Schools, Part 2 is open to any OCT member with one year of successful classroom teaching experience. The member must have successfully completed Religious Education in Catholic Schools, Part 1 OR hold qualifications in Religious Education in Catholic Schools, Intermediate or Senior division.</li> <li>Note: Either course may be audited (no credit granted) by non-teachers.</li> </ul>
How?	These courses will be offered face-to-face in Sault Ste. Marie and through videoconference in the district Monday to Thursday between 8:30 a.m. to 3:30 p.m.

## PAYMENT INFORMATION

For HSCDSB employees, Part 1 is no charge. Part 2 is \$500; Part 2 fee is \$600 for non-HSCDSB employees. Cost is \$100 for non-OCT members (audit only; no credit granted).

Payment must be received prior to commencement of the term. The course will only be offered if there are a minimum of five registrants.

Fees may be paid by cheque payable to the Huron-Superior Catholic District School Board. **HSCDSB employees may also pay through payroll deduction** (initiated prior to course start).
