REPORT TO THE DIRECTOR OF EDUCATION CAFETERIA CONTRACT

Date: February 17th 2021 Submitted by: Justin Pino Superintendent of Business

The Huron-Superior Catholic District School Board's Multi-Year Strategic Plan (MYSP) lists Equitable Stewardship of our Resources as one of its strategic directions. This report relates specifically to aligning available resources with strategic priorities and ensuring schools have the resources they require.

In April 2013, the Board issued an RFP for cafeteria services. There were no proposals submitted from vendors that met the requirements of the RFP.

At that time the Board extended the contract it had with Compass Group Canada for two (2) years effective September 1, 2013, which expired at the end of the 2015 school year.

The RFP did include a clause that gave the Board, at their discretion, an option to renew the contract on an annual basis.

In 2015, with the opening of the new St. Mary's College, it was recommended that the Board renew the contract with Compass Group Canada for three (3) years to provide consistency and stability with the opening of the school.

In August 2017, the agreement was amended, extending the term for two (2) additional years. The term was in effect until and including June, 2020. As a result of the COVID-19 pandemic, the contract was not discussed prior to June 2020.

The quality of services provided by Compass has been validated by the school principal. Needless to say, the COVID-19 pandemic has disrupted cafeteria services at various times during the most recent extension period of the contract, impacting the ability of the Compass Group Canada to provide services. Furthermore, as the board attempts to navigate through the COVID-19 pandemic, now may not be the best time to issue an RFP for Cafeteria services.

It is recommended that the cafeteria contract be extended for a period of two (2) years to expire on June 30th, 2022.

Background

Regulation 304, School Year Calendar, Professional Activity Days requires that each school board prepare, adopt and submit to the Regional Manager of the Ministry of Education on or before the first day of May, the School Year Calendar to be followed in its jurisdiction for the following year.

Information

A consultative process that provided opportunity for all board employees, school communities, parents and trustees to provide feedback on the proposed calendar was completed. A total of 171 surveys with comments and suggestions were received as part of the consultation.


The board also followed a collaborative process with the other District School Boards with whom we need to co-ordinate calendars. Using the feedback from the Huron-Superior Catholic District School Board consultation, the board administration worked through a consensus exercise to come up with a common calendar for board approval.

As per Regulation 304, the proposed calendar for 2021/2022 includes a 194 day school year comprised of 187 instructional days and 7 professional activity days. For the secondary level, exam days are also noted on the calendar. This year, after the consultation with our community, we are recommending the school year calendar "OPTION 1" which is included as part of this report. While Option 1 was very narrowly preferred in our board, it was also the preferred option for the boards in our region. The first day of class would be Tuesday September 7, 2021 and Board Holidays would be scheduled for Wednesday September 1, 2021 and Friday September 3, 2021.

Professional Activity Days would be scheduled for Thursday September 2, 2021, Friday September 24, 2021 (Faith Day), Friday October 29, 2021, Friday February 4, 2022 (assessment), Friday April 29, 2022, Friday May 20, 2022 and Friday June 10, 2022 (assessment).

<u>Proposed Resolution:</u> That the Huron-Superior Catholic District School Board approves the School Year Calendar for the 2021 – 2022 school year, as recommended and outlined in "OPTION 1".
