#### Values and Vision

Trustee Caputo thanked the staff at St. Mary's College, along with the Link Leaders, for their outstanding job in working together as a team to welcome the grade 9 students and all other students back to school. The staff volunteer their time for this great program and it is very much appreciated.

Lina DiPasquale, Vice-Principal of Equity, Diversity and Indigenous Education, highlighted the new Grade 6 Outdoor Education Program running out of St. Kateri in the mornings and Holy Cross Catholic School in the afternoons. There are currently 31 students registered in the course, who enjoy land-based learning, including teachings from elders and other cultural resource workers.

Director Viotto was excited to report on the significant increase in student enrolment for the 2022-23 school year. An additional 225 new students registered in September, which included 87 newcomers to the city. Various cultural and newcomer events were attended by staff over the summer, which helped to attract these students and grow our school community.

Vice-Chair Trembinski commented on the touching ceremonies held for Queen Elizabeth II's funeral. He pointed out how nice it was to witness many different faiths in attendance. The ceremony held in Ottawa was very moving and included many notes from students, of which two Sault Ste. Marie students attended, to acknowledge the Queen's passing.

## REPORT TO THE DIRECTOR OF EDUCATION Trustee Honoraria

Date: October 19<sup>th</sup> 2022 Submitted by: Justin Pino Superintendent of Business

The Huron-Superior Catholic District School Board's Multi-Year Strategic Plan (MYSP) lists Equitable Stewardship of our Resources as one of its strategic directions. This report relates specifically to utilizing resources responsibly, justly, responsively, and wisely.

Ontario Regulation 357/06 of the Education Act requires school boards to adopt a policy establishing the honoraria for its members during their term of office. There are four components to trustee honoraria which a board may pay as follows:

- The base amount for the year.
- The enrolment amount for the year.
- The attendance amounts payable to a member for the year.
- The distance amount payable to a member for the year.

According to board Policy 2004 (Trustee Honoraria), the board will only pay its members the base and enrolment amounts.
